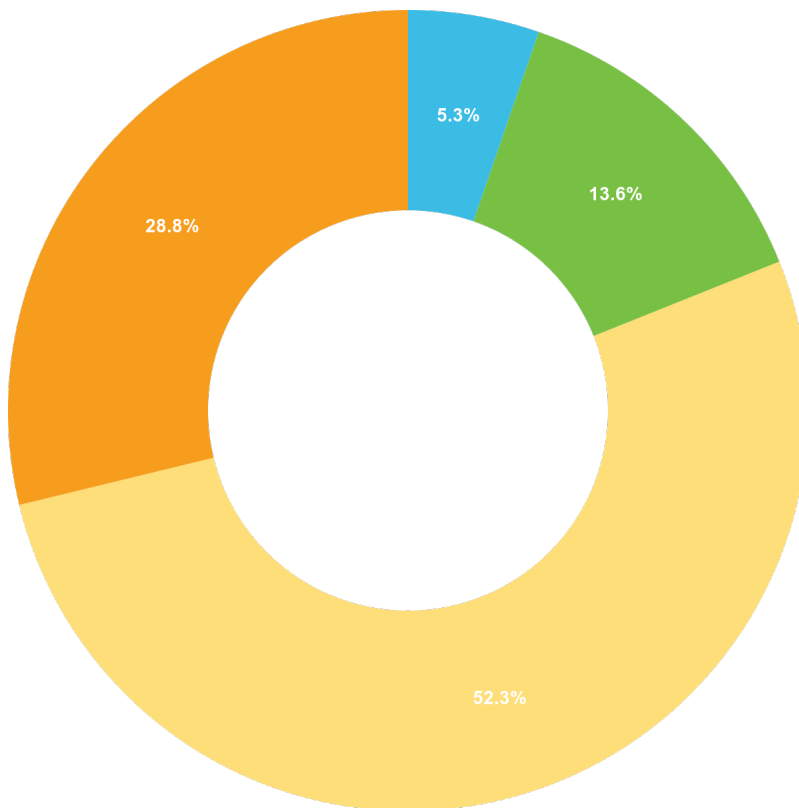

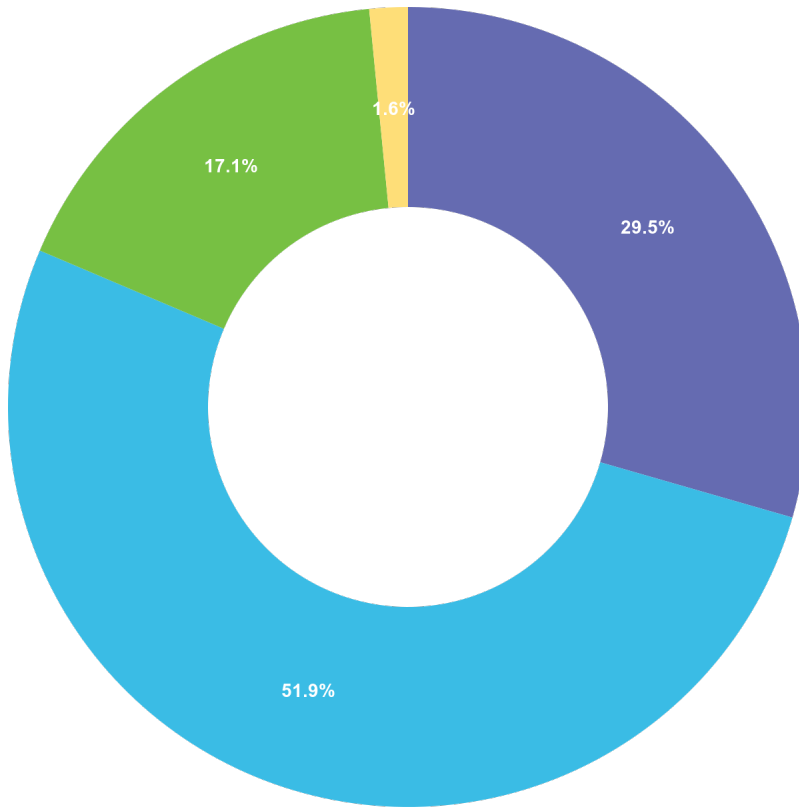
Q1 How often do you use the library?*

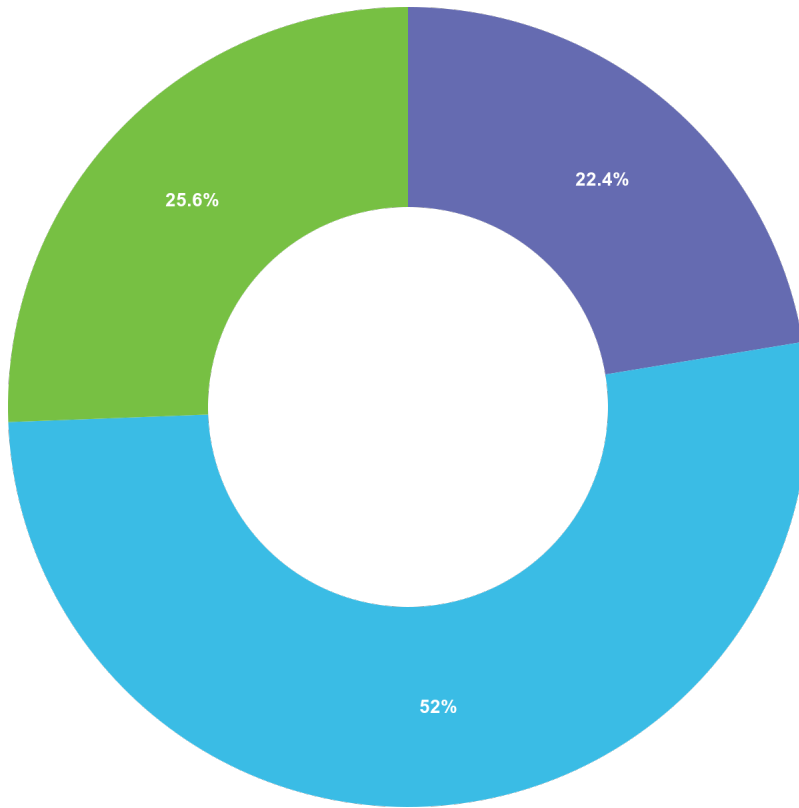
Q2 How would you rate the general appearance of the Scenic Hills Community common areas?

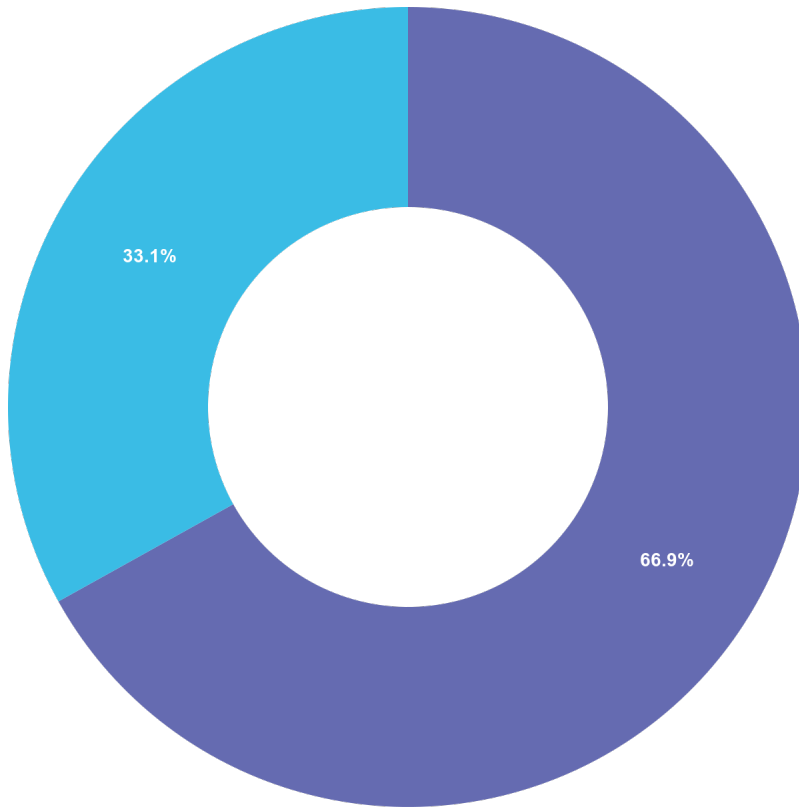
Q3 Would you like more Large Print book?

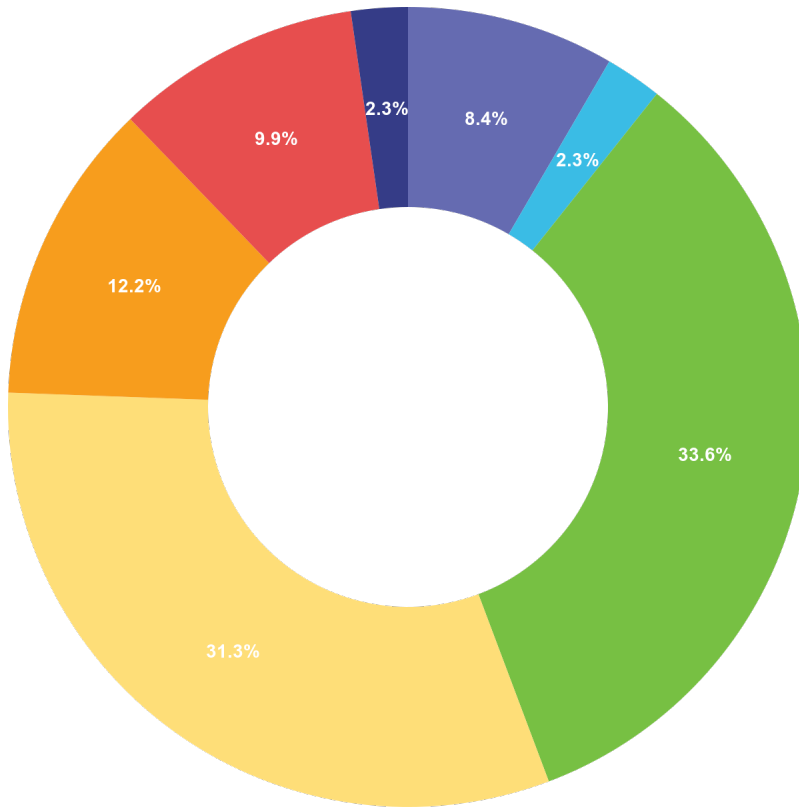
Q4 Do you think the Association should require Residents to remove dead plant material?

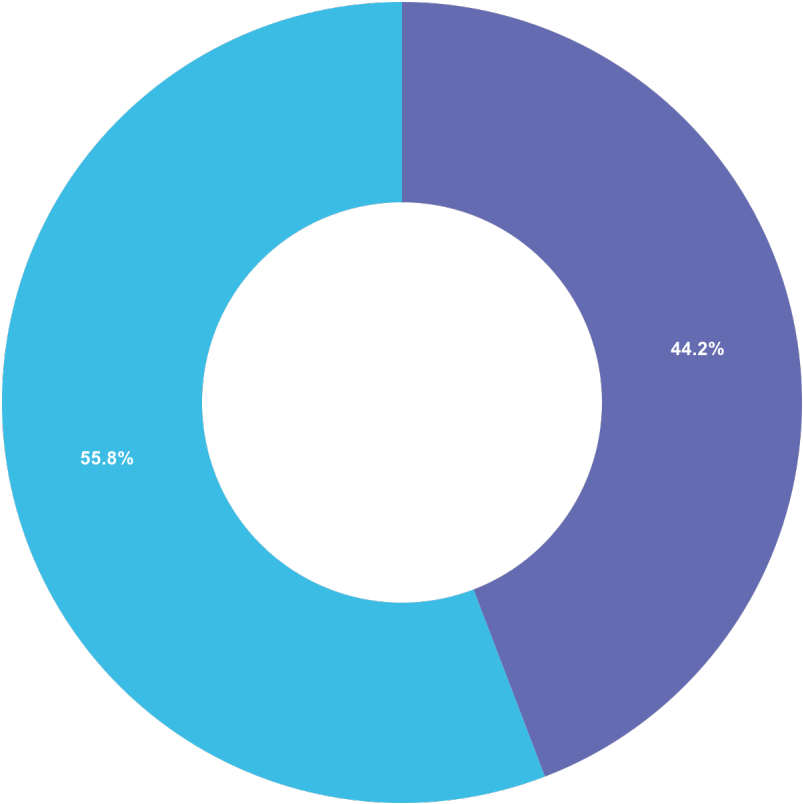
Q5 How long have you lived in Scenic Hills?

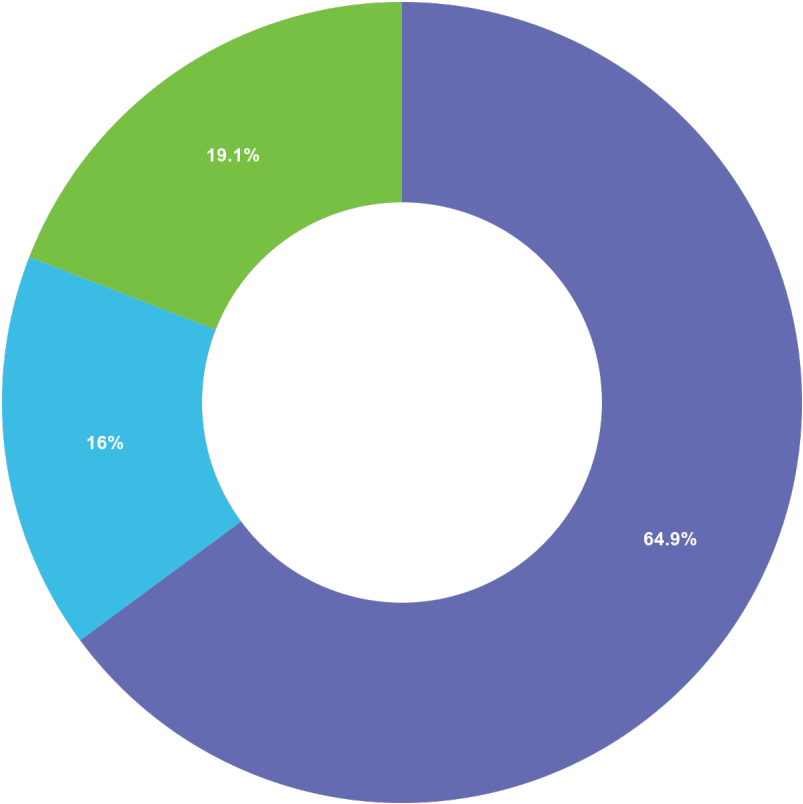
Q6 Do you think the Association should require pots to be removed if they do not have anything in them, (yard art excluded)?

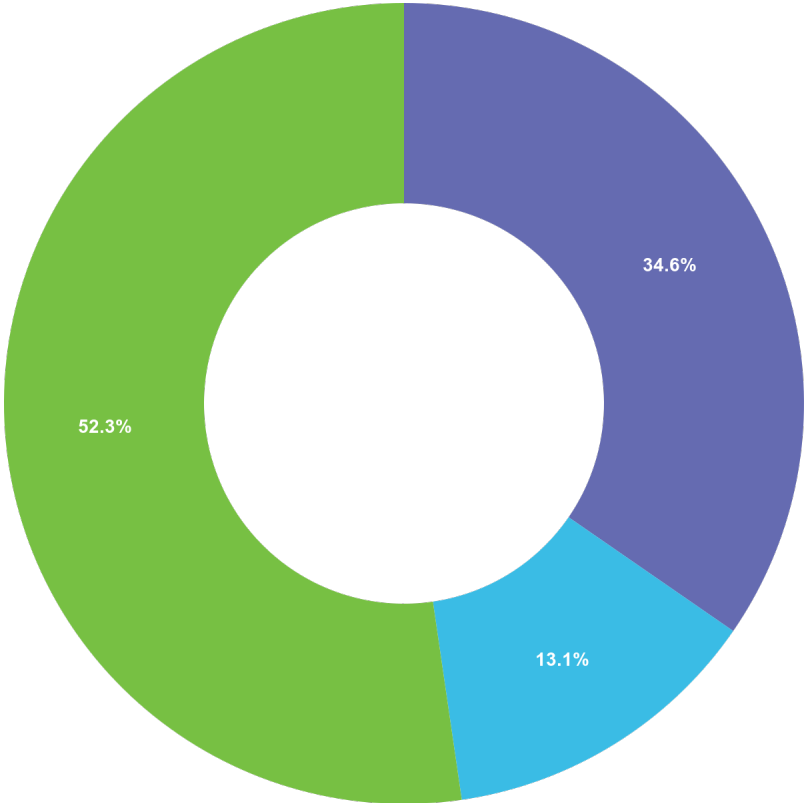
Q7 Do you think the members of your governing board strive to serve the best interests of the community as a whole?

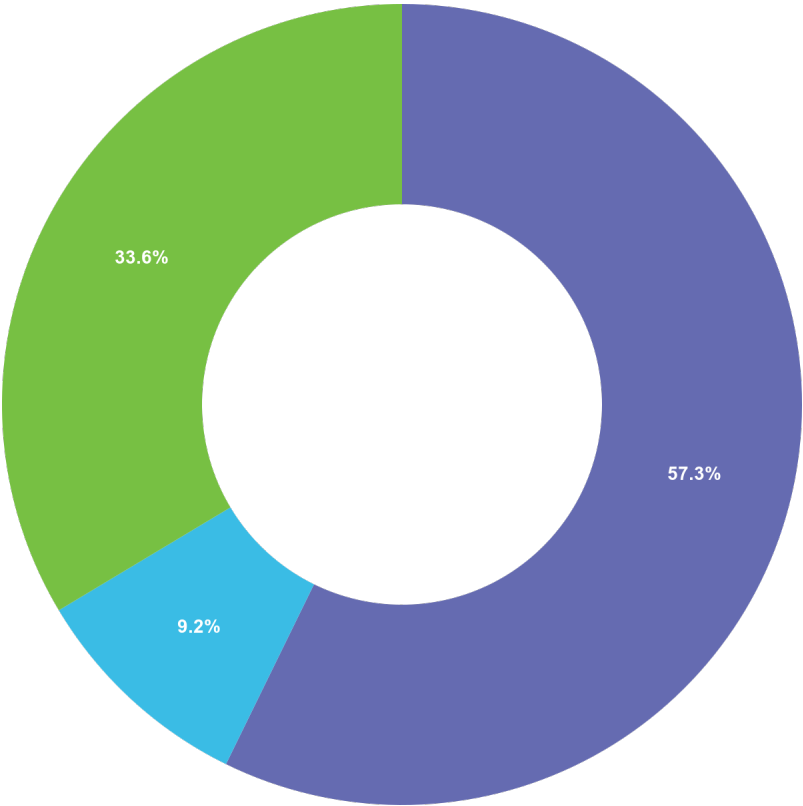
Q8 If you had to choose, would you rather have...

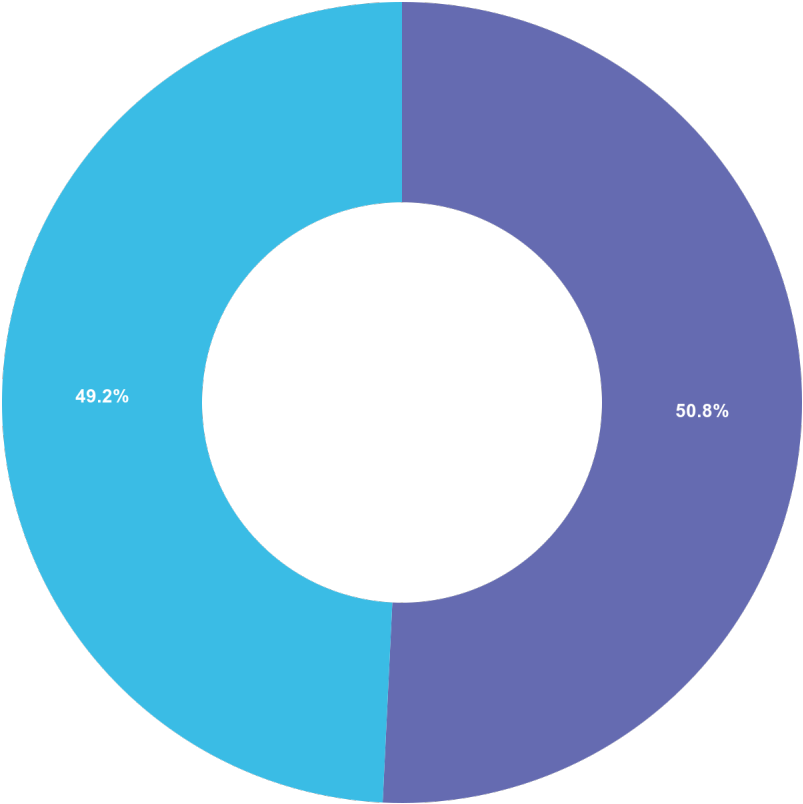
Q9 Thinking about the amount of your overall assessments that you pay for the services provided by your association, do you feel the amount of your assessments is too much, too little, or just the right amount?

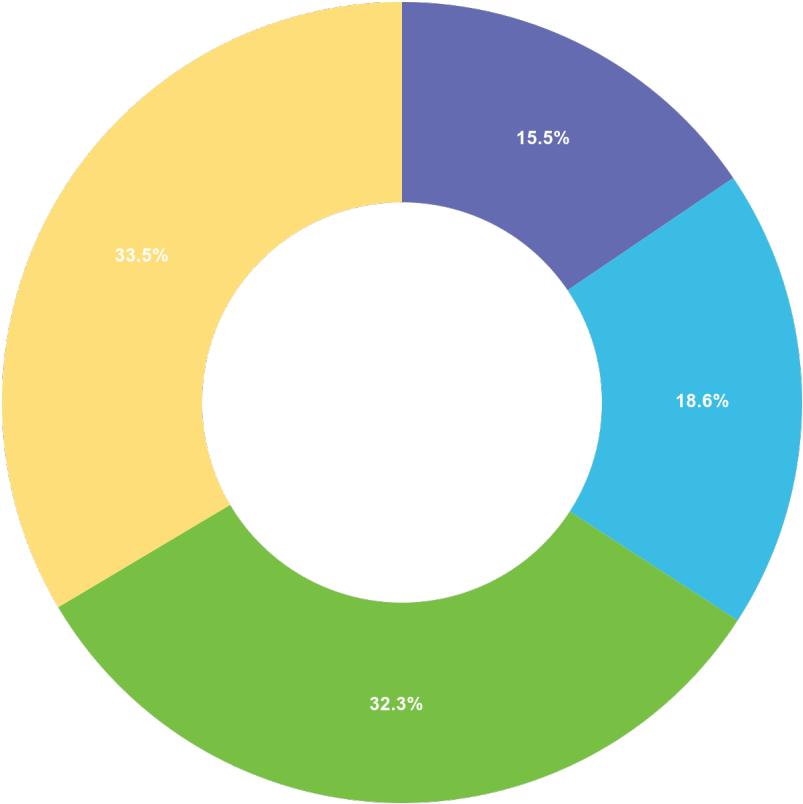
Q10 Do you think the Association should have a restriction that does not allow window mounted air conditioners on the front or side of the house?

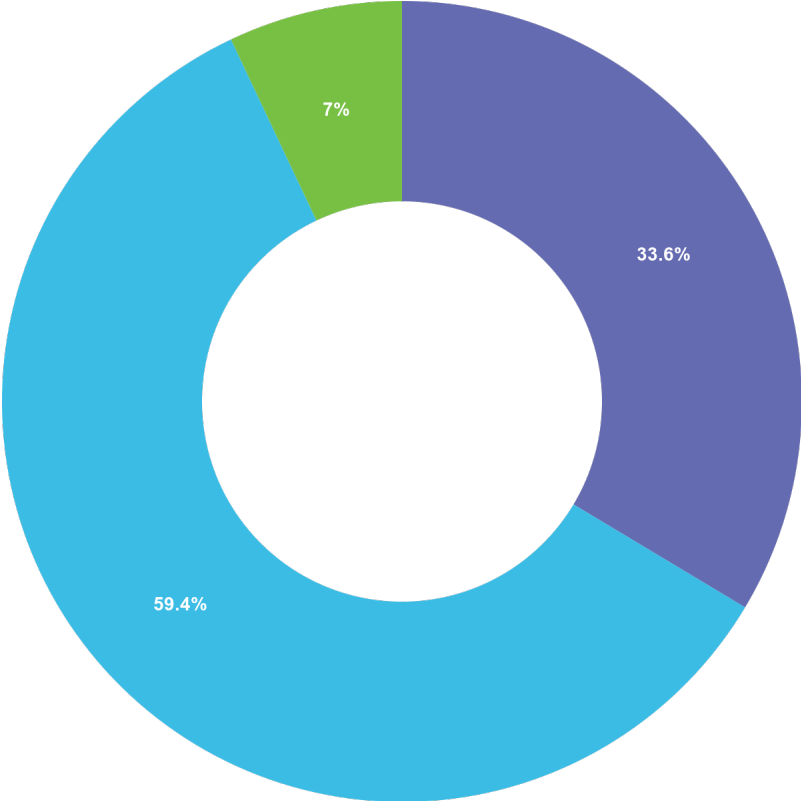
Q11 Have you or anyone in your household served the community in any of the listed capacities?

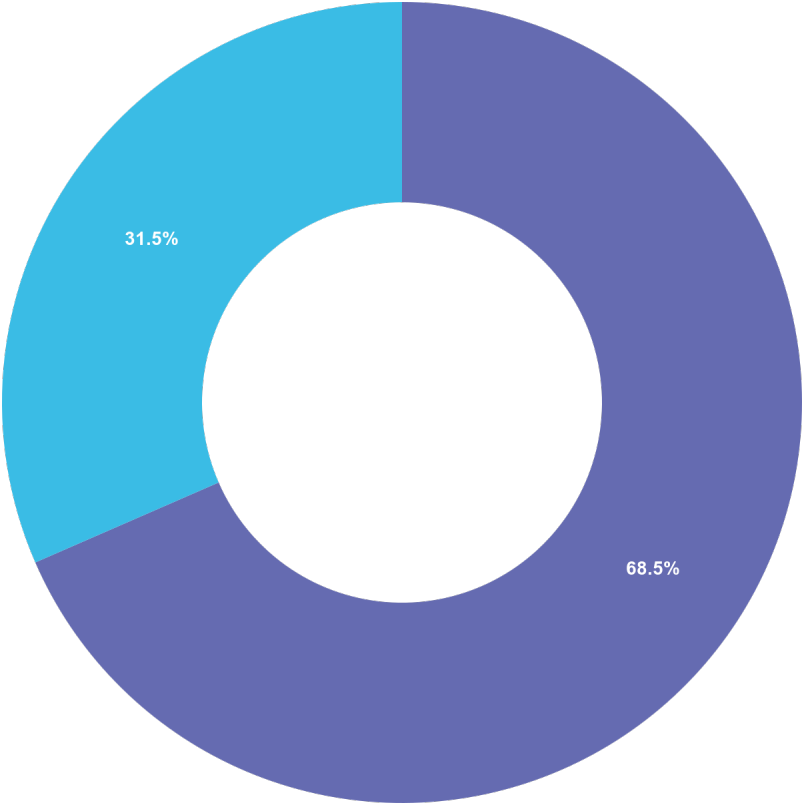
Q12 Would a community garden be a project you would be interested in?

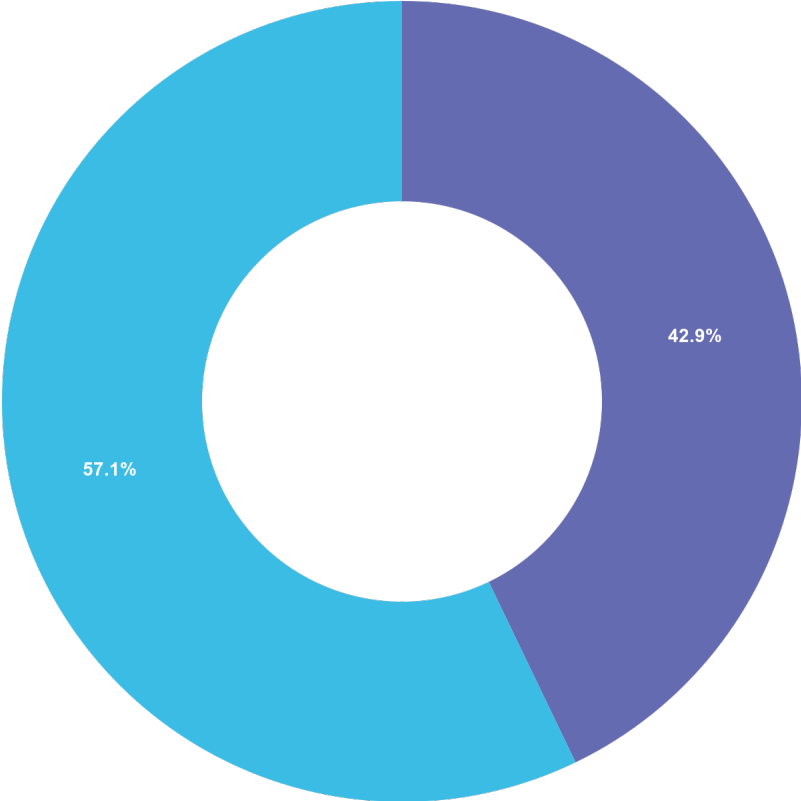
Q13 Do you think the Association should require trash cans/recycle containers to be stored so that they are not visible from the street?

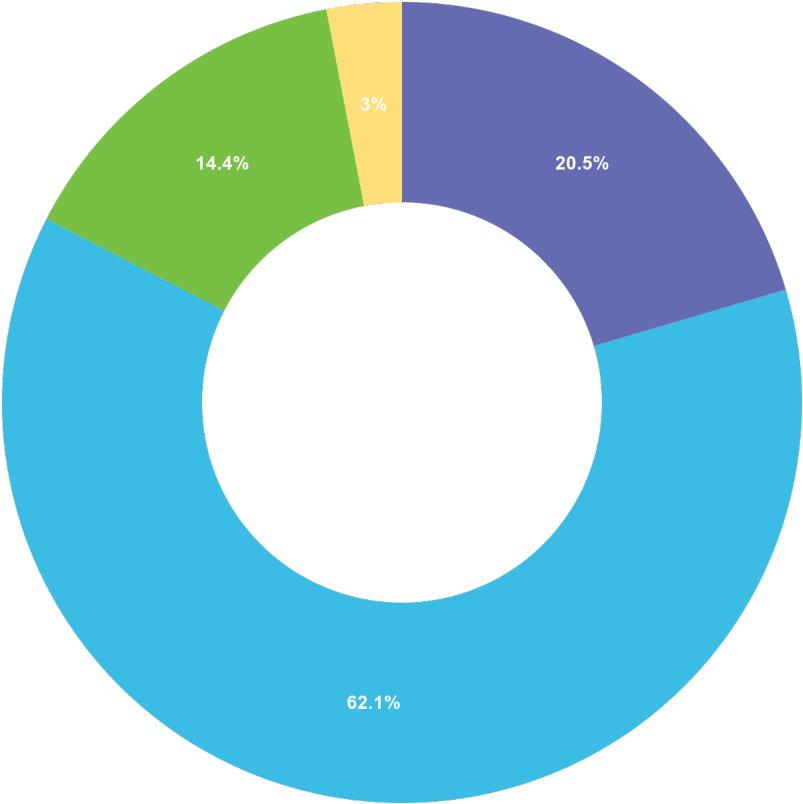
