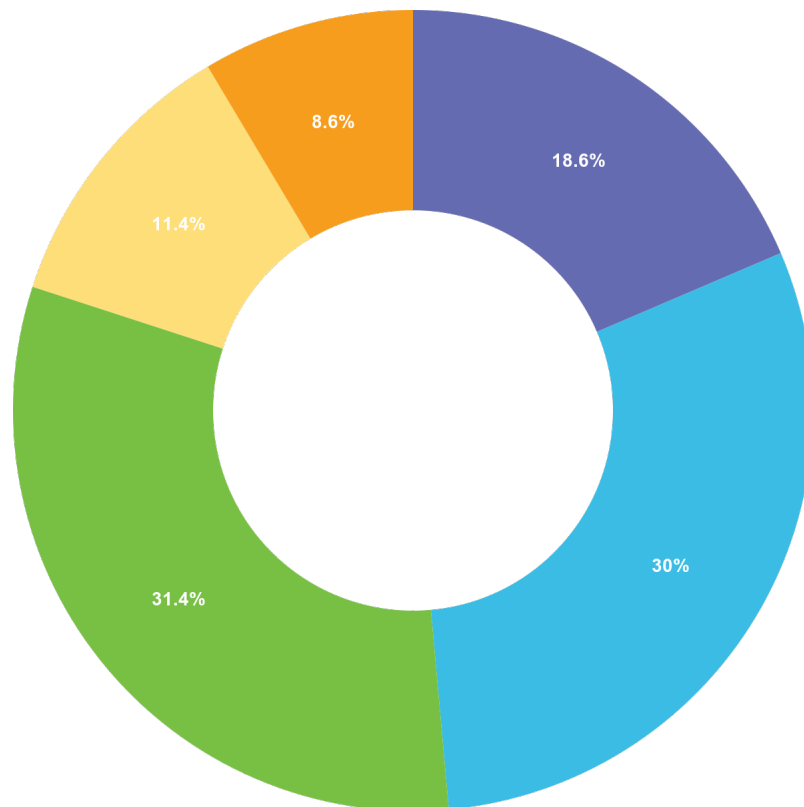


# Scenic Hills Pool Policy Survey

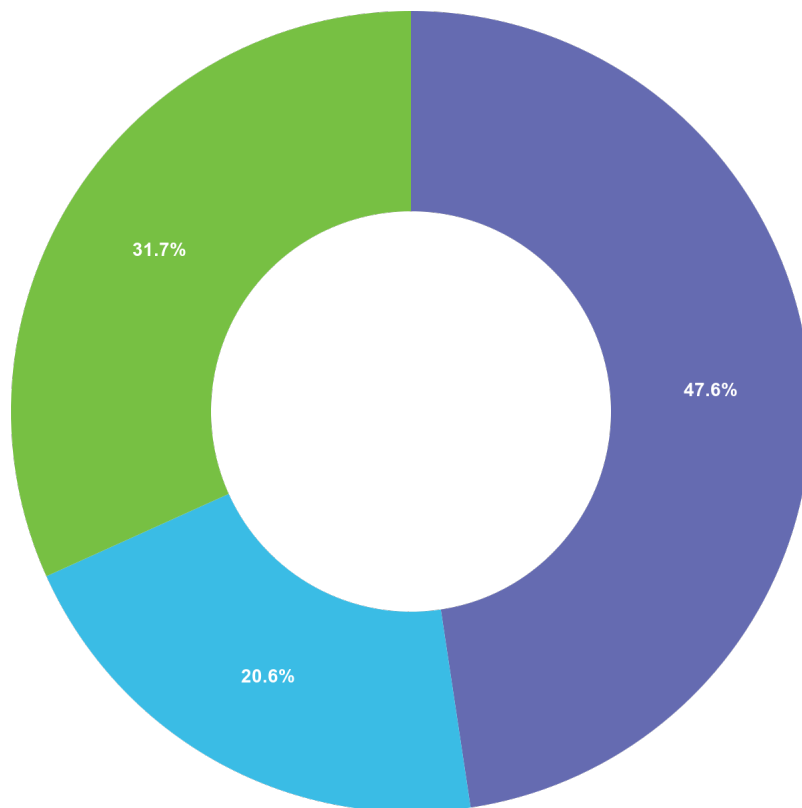

**Q3** Which of the following statements do you agree with most?

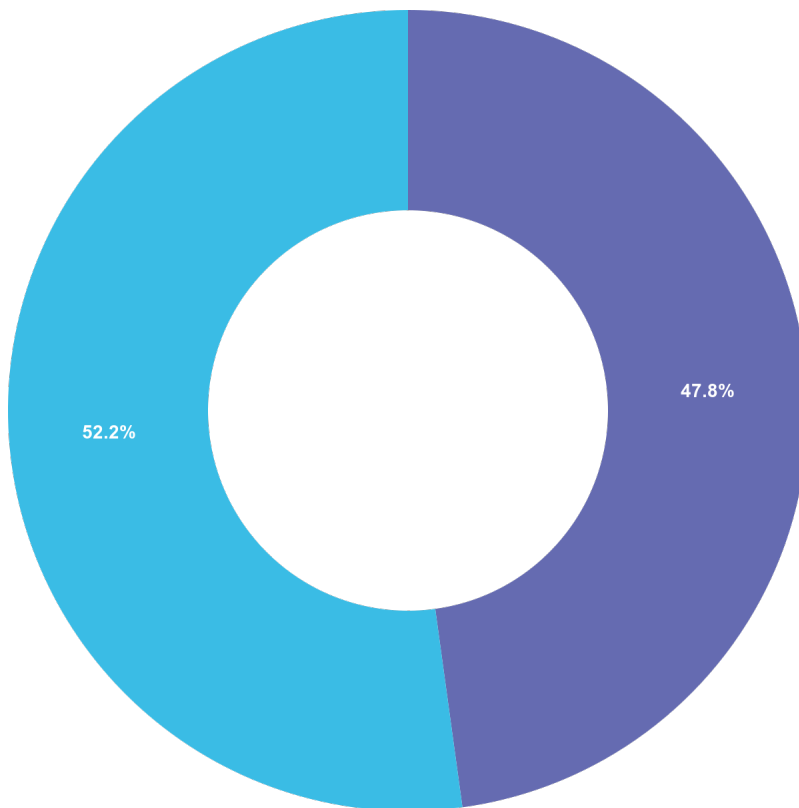

**Q4** Should the pool be available for resident private parties?

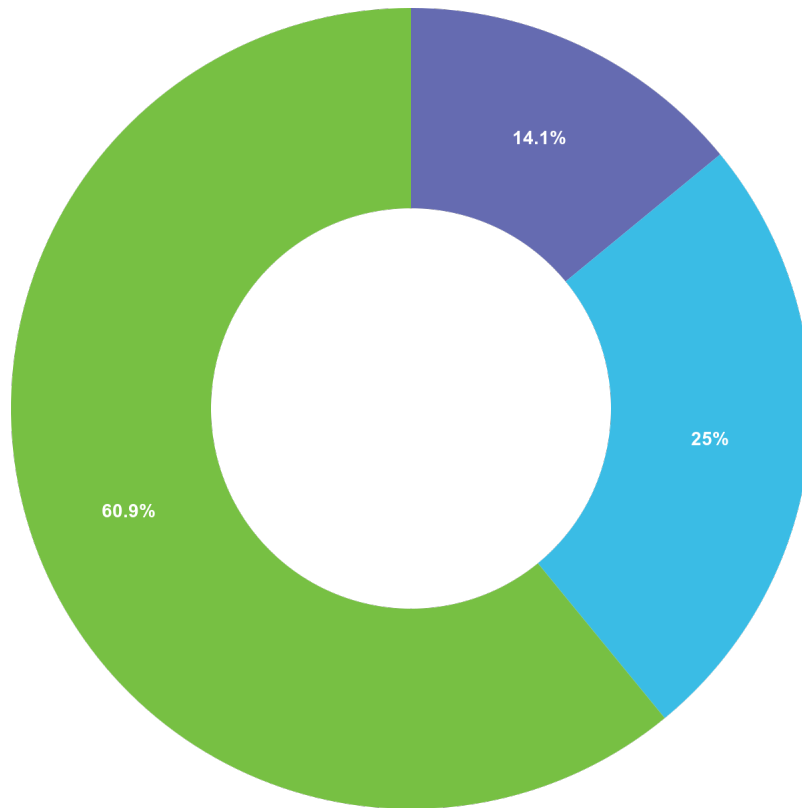

**Q5** Regarding play toys (e.g., Frisbees, rings, beach balls), which of the following statements do agree with most?

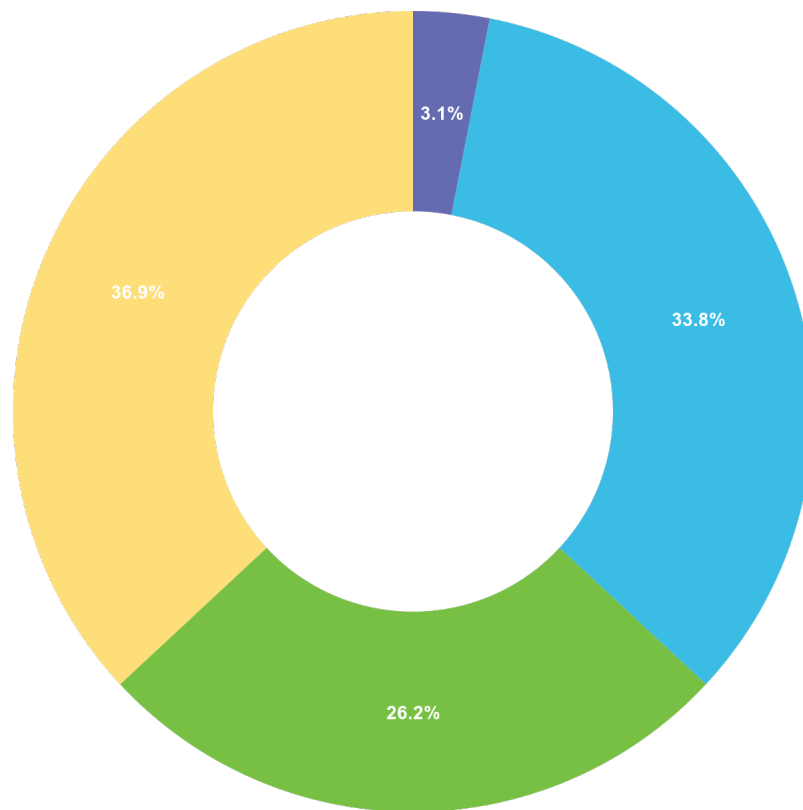

**Q6** Should the pool and/or portions of the pool area be closed while a class or activity is being conducted? Check the answer that you agree with most.

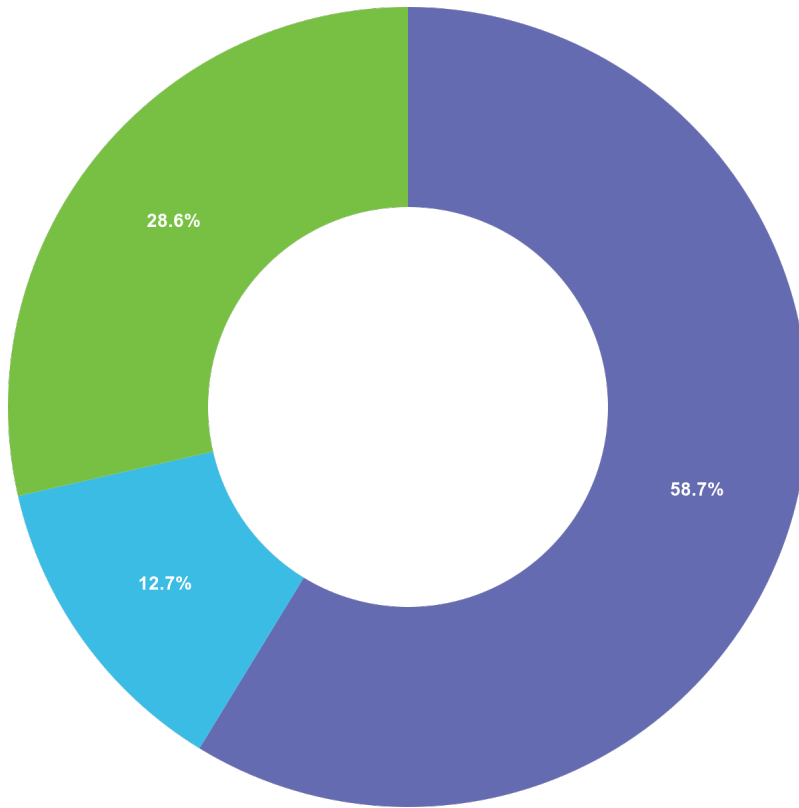

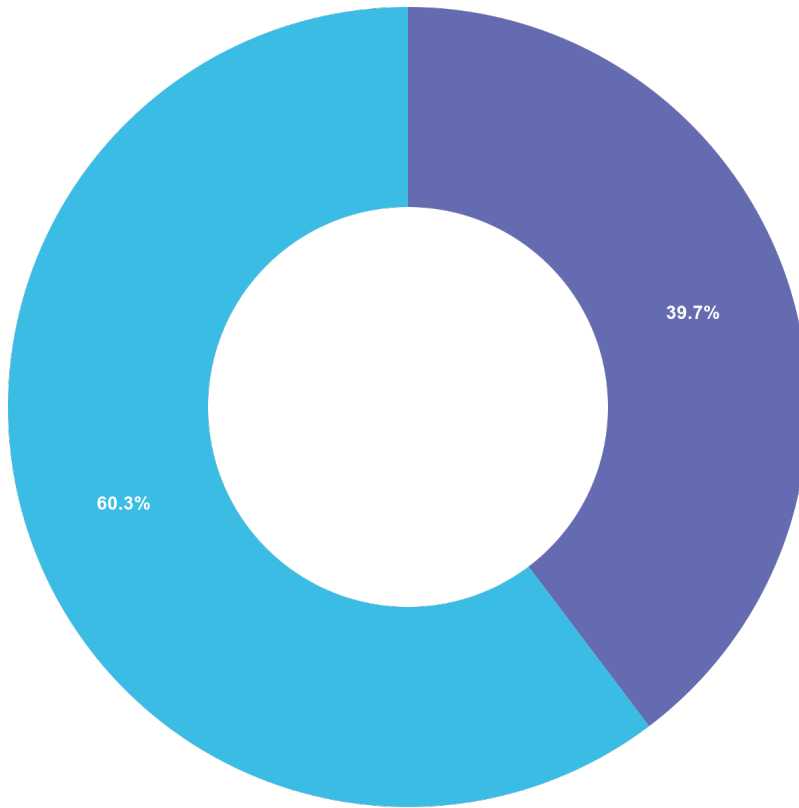

**Q8** Do you think there should be specific times when only adults may be in the pool?



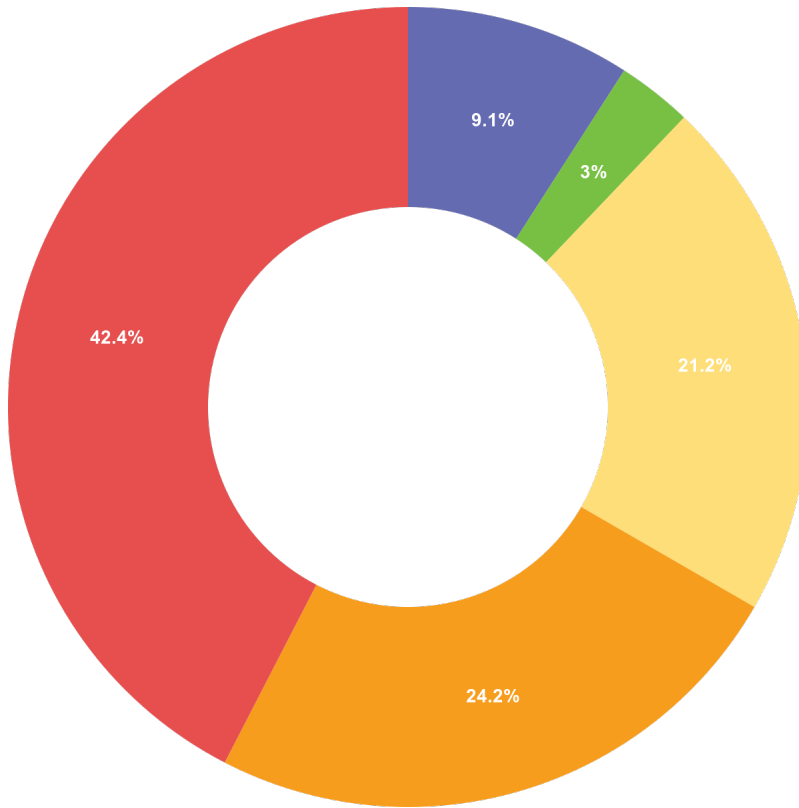
