

Town Hall Meeting Notes from Tuesday, May 21, 2024 Meeting Includes Homeowners' Forum & Committee Reports

Homeowner's Forum

- Resident
 - Re: recent surveys you don't have the ability to go backwards in the survey to change your mind; can we look into the
 possibility of enabling that?
 - Board Response: Sorry, but we're using a free product and it doesn't allow that. We would have to pay for another survey software that has that feature and we're not willing to do that.
 - Re: recent surveys I thought it was just lawn care, but you included pots, etc.
 - Board Response: The survey was called Landscaping and Lawn Care pots, etc. is landscaping.
- Resident
 - What's the result and status of the columns on the portico?
 - Board Response:
 - We're still working with our insurance company and their insurance company.
 - Their insurance company said they'd pay for 10ft, we're trying to get them to pay for more.
 - Cost to repair will be approx. \$12K; we're working diligently to get it fixed; insurance company agreed to pay approx. only \$2K.
 - There is no structural damage to the columns, just cosmetic damage.
- Resident
 - Wants to voice concerns without giving the Board an opportunity to respond:
 - Lawn glad to hear we're working on new lawn service.
 - Roof glad to hear we're working on it.
 - Pool really question the timing to have the pool fixed now and there have been people who wanted to use it.
 - Dining Room we've spent lots of \$\$ removing the popcorn on the ceiling and she questions the quality of the work; there's a crack on the ceiling.
 - Sidewalks on community appears that work has started but there are barricades up but she doesn't know if they were put up by our contractors or the city.
 - Locks on the irrigation she feels like it's insulting she thinks we're taking a shotgun approach.
 - ACC she feels like residents are reluctant to plant, place, replace, etc. because of the heavy handedness approach
 we're taking.
 - As good stewards, our HOA fees are among the higher in the nation we're higher than average; we've had increases and 2 special assessments.
 - Resident
 - When is the roof RFP going to go out?
 - Board Response:
 - Yes, we have a tentative firm date we're working on getting the RFP out and something committed by the end of June.
 - The challenge is that things are more difficult for a corporation than they are for an individual. As an individual you can request a bid and let a contract in a couple of days. As a corporation, the RFP must be reviewed by many people, then the bids must be evaluated by a number of people, presented to the Board and the Board must make the decision.
 - Re: Pool why isn't it done?
 - Board Response:
 - To stay within our budget we allowed the contractor to "work us in", so between our rainy days and the contractor having other priorities, our pool has been delayed.
 - Additionally, we had to do the pool now; to wait longer, it likely would have cost us considerably more.
 - Resident
 - Re: Roofing do we have an insurance policy, so we can file a claim on the roof?
 - Board Response: Yes, and we have filed a claim.
 - Re: She has a problem in her yard that was made by a cut in the spillway. The spillway has degraded substantially. Will the Board hold her responsible for repairing that spillway that was damaged as a result of a cut made by the irrigation people?
